You must enter into this Agreement if you want to submit digital images or other content to the Center for Canine Behavior Studies, Inc.. This is a legal contract ("the Agreement") between you and the Center for Canine Behavior Studies, Inc. ("CCBS"). By submitting any image or video file to CCBS or any of CCBS's various marketing and social media channels you indicate your agreement to all of the following terms and conditions.

As used in this Agreement, "we" or "CCBS" means the Center for Canine Behavior Studies, Inc.. and "you" means the individual or entity submitting materials to CCBS. Any individual or entity that wants to submit content to CCBS must accept the terms of this Agreement without change.

You agree to indemnify CCBS and its officers and employees against any claims, damages or any other costs whatsoever related to any claim of copyright infringement related to the Files.
